Then the Grant for New Business could be for you!

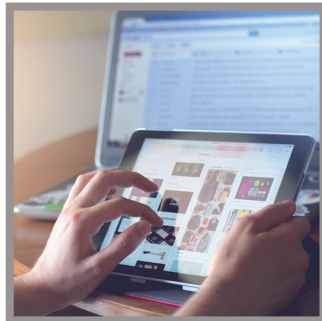
The NBV Grant for New Business supports start-up businesses based in Nottinghamshire, Derbyshire, Leicestershire and greater Lincolnshire.

If you can say **YES** to these:

- **Ready to start trading**
- **You will sell business to business NOT business to Customer/Retail**
- **Your business is based in Derbyshire, Leicestershire, Lincolnshire or Nottinghamshire**
- **Your business is registered with Companies House or HMRC**

We could say **YES** to you!

## What can the grant be used for?



### EQUIPMENT

You could use the grant for equipment to meet your clients' needs:

- Computer hardware/software
- Tools/machinery
- Monitoring/measuring apparatus

### CONSULTANCY SERVICES

To help your business plan for success:

- Marketing plan
- IT projects
- Sales strategy

## HOW MUCH FUNDING IS AVAILABLE?

Grants of between £1000 and £2500 are available. This is for a maximum of 25% of eligible costs. Thus, in order to access the business grant, the minimum project spend is £4000.

Example:

Project Spend	Grant Claimable
£1,000	Not eligible
£3,000	Not eligible
£4,000	£1,000 (grant minimum)
£5,000	£1,250
£7,500	£1,875
£10,000	£2,500
£10,001+	£2,500 (grant maximum)

## MATCH FUNDING

You will be required to pay the supplier for the full cost of the project before claiming the grant element. It is, therefore, vital that funds are in place to cover these costs prior to submitting the application.

No retrospective applications will be considered.

## HOW DO I APPLY?

Stage 1 of the application process is to complete an expression of interest and submit this to NBV. Basic eligibility checks will be carried out and, if successful at this stage, you will be asked to complete a full application.

Full applications consist of an Application Form with supporting evidence in the form of 3 quotations for items required. NBV staff will support you in completion of the application and are on hand to answer questions throughout the application process.

Once submitted the application will be considered by the Grant Panel who will meet to discuss all applications and decide which businesses are supported according to the funds available.

N.B. The Grant is financed by the European Regional Development Fund (ERDF) and is subject to European Funding regulations.

## Grant Restrictions:

The following areas are known to be **NOT eligible** items:

- Vehicles and other mobile infrastructures.
- Essential running costs i.e: insurance, statutory obligations, utility bills, salary costs, overheads, recruitment fees, tax.
- Stock.
- Accredited training.
- Cost for items that go beyond the period of the grant.

Further sector restrictions also apply. This list is not exhaustive and further eligibility criteria do apply.
